Re: Further information on Covid-19 in schools

We are writing to you with some more information on how our schools will operate, following the government's recent announcement on the easing of restrictions.

Contact tracing and self-isolation

The government has changed how contact tracing will happen and the requirements for self-isolation when a person is identified as a contact of a positive case. From **Monday 19 July 2021**, responsibility for contact tracing will pass from schools to NHS Test and Trace. Therefore, if your child tests positive for Covid-19, you should contact NHS Test and Trace and your child should not attend school. Please report their absence through the school's normal absence reporting procedures.

Should your child become a contact of a positive case, you should hear from NHS Track and Trace and should follow instructions from them. Until 16 August, it remains a legal requirement to self-isolate if directed by NHS Test and Trace. If your child is asked to isolate, please inform the school through normal absence reporting procedures.

From 16 August 2021, children under the age of 18 years old will no longer be required to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case. Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test. We would encourage all individuals to take a PCR test if advised to do so. *Please note that any person self-isolating as a result of becoming a potential contact of a case before Monday 19 July, must complete the full period of isolation and cannot cut that period short and return to school.*

Continuing existing controls

You are probably aware that rates of Covid infections amongst young people in Yorkshire are higher now than at any point during the pandemic and are continuing to rise rapidly. This is causing increasingly high numbers of students being required to self-isolate. Between now and the end of term, we will continue to do everything we can, to reduce the risk of the spread of the virus and keep as many young people as possible in school. We also wish to minimise the risk of students being required to isolate during the first part of the school holidays. We have been given very clear advice from Public Health teams across four Humber authorities to retain all existing control measures until the end of this term. We will therefore maintain our existing arrangements including staggered starts and lunchtimes, face coverings in communal areas in secondary schools and maintaining separation between students in different year groups.
