Re: UK Parliament Visit

I hope this letter finds you well. The History department is pleased to be able to offer your child the opportunity to visit the UK Parliament Buildings in London. The visit is scheduled to take place on Friday 21 March 2025. The purpose of this visit is to develop student understanding of the UK parliament which is related to their A Level Government and Politics course. We are also opening it up to some Year 11 students who are considering studying A Level Politics next year. **There are only 33 places in total on the trip.**

We will be travelling to Westminster, London, by coach and departing from school at 7.00am. We are booked onto a tour and workshop at 1.25pm, with the session finishing at 3.40pm. Following the session, we will take students for an early tea at Pizza Express, Millbank, which is a short walk from the Houses of Parliament. Included in the visit price is a 2-course set menu. This does not include a drink so students will need to bring a small amount of money should they wish to purchase a soft drink or other refreshments throughout the day. We will then leave London via coach at 6.00pm with the estimated arrival time at school around 12 midnight.
