#### **South Hunsley Provider Access Statement**

#### Introduction

This policy statement sets out the school's arrangements for managing the access of providers to the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

#### Pupil entitlement

All pupils in years 7 to 13 are entitled:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events.
- to understand how to make applications for the full range of academic and technical courses.

For pupils of compulsory school age these encounters are **mandatory** and there will be a **minimum of two** encounters for pupils during the 'first key phase' (Year 8 to 9) and two encounters for pupils during the 'second key phase' (Year 10 to 11).

For pupils in the 'third key phase' (Year 12 to 13), particularly those that have not yet decided on their next steps, there are two more provider encounters available during this period, which are optional for pupils to attend. All of these encounters will happen before 28 February of the final year of each key phase i.e. Year 8 and Year 9 pupils will have their encounter before 28 February in Year 9.

These provider encounters will be scheduled during the main school hours and the provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- · explain what career routes those options could lead to
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and pupils from the provider)
- · answer questions from pupils.

#### Meaningful provider encounters

One encounter is defined as one meeting/session between pupils and one provider. We are committed to providing meaningful encounters to all pupils using the making it meaningful checklist.

Meaningful online engagement is also an option, and we are open to providers that are able to provide live online engagement with our pupils.

#### **Destinations of our pupils**

Last year our Year 11 pupils moved to range of providers in the local area:

- The largest proportion of pupils continued to study at South Hunsley Sixth Form College
- A number of pupils when on to further education colleges such as East Riding College, Bishop Burton and Hull College
- A slightly smaller number of pupils continued to pupil A-levels or BTEC's at other sixth form colleges
- A small number of pupils gained apprenticeships
- A small number of pupils went in to full time employment

Last year our Year 13 pupils moved to a wide range of providers:

- The large majority of our pupils go onto higher education
- 78% of those who applied to university were placed at their first choice
- 27% of our university applicants were placed at Russell Group Universities
- All medics and veterinary applicants and all Oxbridge applicants who were offered places were successful in achieving the grades needed to secure their places
- 8 pupils secured higher level apprenticeships and an increasing number of pupils secured an
  apprenticeship or employment with firms that included Barclays, BAE, Smailes Goulding, Howden
  and Jackson's Bakery.
